CALL TO ORDER:

1. APPROVAL OF AGENDA:

Item 22-06-01 Applicant: Beaurin Subdivision

Item 22-06-04 Applicant: Armstrong Subdivision

With recommendation in favour from staff and no comments or concerns from the committee;
